The information collected is used solely for communicating with you as the intended party. We do not share your information with external parties for marketing or any other purposes. Additionally, no mobile or messaging consent information will be shared with third parties/affiliates for marketing/promotional purposes. All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties. We may use personal data for the following purposes:

- 1. To provide and maintain our service, including monitoring the usage of our service.
- 2. To manage your Account: to manage your registration as a user of the Service. The Personal Data you provide can give you access to various functionalities of the Service available to registered users.
- 3. For the performance of a contract: the development, compliance, and undertaking of the purchase contract for the products, items, or services you have purchased or of any other contract with us through the Service.
- 4. - 6. When we believe it is necessary to disclose Personal Information to investigate, prevent, or act regarding illegal activities, suspected fraud, potential threats to anyone's physical safety, violations of Allpine Lumber Company Terms of Service, or as otherwise required by law.
- 7. We transfer Personal Information about you if Allpine Lumber Company or its assets are acquired by or merged with another company. We may share aggregated, non-identifiable information with others without further notice to you, such as the total number of people who used the Service in a specific month or the total number of messages sent during a particular period.
